I hereby agree to exhibit during the following dates: **Sunday, August 6 through Saturday, August 12, 2017**. Set-up can begin Sunday, August 6 **AFTER 12:00 PM**. **EARLY SET-UPS MAY NEED TO BE MOVED IF NOT IN THE CORRECT LOCATION!**

All concessions and exhibits are to be on the grounds by **NOON** and set up for business Monday, August 8, 2016 or reservations and deposit will be forfeited, unless special arrangements are made.

To guarantee your space for **2017**, it is imperative that we receive 50% deposit along with a signed rental agreement, insurance information and number of Paid Parking Passes by **May 15<sup>th</sup>**.

All display and/or concession fees shall be paid in full by Saturday, August 5, 2017. **NO REFUNDS**.

No fair security will be provided after 6:00 AM Sunday, August 13, 2017. Remove all equipment and concessions on **Saturday night AFTER 10:00 P.M.** or Sunday from 2:00-4:00 PM. **NO EARLY DEPARTURES OF CONCESSIONS (INSIDE OR OUTSIDE)**.

**BRING YOUR OWN** special equipment, tables, extension cords, light bulbs, water hoses or any other items pertinent to your concession. There will NOT be any available. **ALL CONCESSION GARBAGE MUST BE REMOVED BY CONCESSIONAIRE OR YOU WILL BE SENT A BILL FOR REMOVAL.**

The undersigned agrees to indemnify and hold harmless the Mifflin County Youth Fair Committee and the Mifflin County Youth Park Association from all liability by reason of any loss, damage, or theft, which results from the negligence of the undersigned for the Youth Park Association of the Youth Fair Committee.

The undersigned further acknowledges that all exhibitors, concessionaires, or employees of exhibitors or concessionaires under contract with the Mifflin County Youth Fair Committee are legally considered as employers of their own equity, and as such are required by law to provide their own liability and Workmen's Compensation insurance.
